

**ORDINANCE NO. 2012-15**

AN ORDINANCE AMENDING ORDINANCE 2010-45, 2011-14, 2012-07 AND 2012-13 CREATING NOT TO EXCEED (NTE) PAY LEVELS AND SALARY SCHEDULES FOR EMPLOYEES OF THE VILLAGE OF BUCKEYE LAKE, OHIO

Be It Ordained by the Village of Buckeye Lake, State of Ohio:

SECTION 1: Ordinance 2010-45, 2011-14 and 2012-07 are amended and the following pay levels and schedules are hereby adopted:

Fire Chief NTE \$450.00/month  
Assistant Fire Chief NTE \$250.00/month  
EMT NTE \$9.25/hr.  
Advanced EMT NTE \$10.00/hr.  
Medic NTE \$10.75/hr.

SECTION II: That the pay increases for the Street Worker, Street Superintendent, Water Department Supervisor and Water Department Worker positions will be retroactive to August 1, 2012.

SECTION III: That this Ordinance shall become effective from and after the earliest period provided by law.
