

**VILLAGE OF BUCKEYE LAKE, OHIO**  
**ORDINANCE NUMBER 2015-05**

AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO ADVERTISE FOR BIDS FOR RESIDENTIAL TRASH COLLECTION AND DISPOSAL WITHIN THE VILLAGE OF BUCKEYE LAKE, OHIO, ACCORDING TO SPECIFICATIONS NOW ON FILE AT THE BUCKEYE LAKE VILLAGE OFFICE AND DECLARING AN EMERGENCY

WHEREAS, refuse collection is a service imperative to the health, safety, and welfare of our residents; and

WHEREAS, our current refuse hauler has sold their company to Waste Management; and

WHEREAS, our current refuse contract is not able to be assigned to a new hauler without the express written consent of the Village of Buckeye Lake; and

WHEREAS, it is council's wish to advertise for bids to attempt to secure the most competitive pricing and terms for our refuse hauling contract.

THEREFORE, FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST TWO THIRDS (2/3) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER SECTION 4.04 TO READ AN ORDINANCE ON THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN READINGS,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, OHIO:

SECTION 1: That the Mayor is hereby authorized and directed to advertise for bids for residential trash collection and disposal within the Village of Buckeye Lake, Ohio, according to specifications now on file at the Buckeye Lake Village Office.

SECTION 2: That in order to protect the health, safety and welfare of the citizens of the Village of Buckeye Lake this Resolution is declared to be an emergency measure and it shall become effective on its passage and signature of the Mayor.
