

**ORDINANCE NO. 2013-04**

AN ORDINANCE AMENDING ORDINANCE 2010-45, 2011-14, 2012-07, 2012-13, 2012-15 AND 2013-01 CREATING PAY LEVELS AND SALARY SCHEDULES FOR EMPLOYEES OF THE VILLAGE OF BUCKEYE LAKE, OHIO

Be It Ordained by the Village of Buckeye Lake, State of Ohio:

SECTION 1: Ordinance 2010-45, 2011-14, 2012-07, 2012-13, 2012-15 and 2013-01 are amended and the following pay levels and schedules are hereby adopted:

SECTION II: - That the rate of pay for this Ordinance will become retroactive to January 11, 2013, for the Clerk/Treasurer, retroactive to March 1, 2013 for the Council Clerk/Mayor's Court Clerk, retroactive to March 1, 2013 for the Water Department Clerk and retroactive to April 1, 2013 for the Police Sergeant.

SECTION III: - That this Ordinance shall become effective from and after the earliest period provided by law.
