**A RESOLUTION ESTABLISHING A SAFETY POLICY FOR THE
VILLAGE OF BUCKEYE LAKE**

WHEREAS, the Village of Buckeye Lake has always and shall continue to hold safety as one of our most important responsibilities in the operation of this organization; and

WHEREAS, the Village of Buckeye Lake firmly believes that productivity and safety go hand-in-hand and that a safe work environment leads to improved performance. At this time, a renewed effort must be placed on safety by every employee in our organization; and

WHEREAS, safety requires not only that each employee performs tasks with safety in mind, but also that each of us is aware of our work environment. Each employee needs to be actively involved with the safety of others by recognizing hazards and understanding it is your responsibility to make supervision aware of any unsafe condition you have identified.; and


WHEREAS, the Village of Buckeye Lake management team commits to knowing, observing and enforcing all safe work practices by setting examples through their own conduct.


NOW THEREFORE BE IT RESOLVED by the VILLAGE OF BUCKEYE LAKE COUNCIL of the Village of Buckeye Lake, Ohio as follows:

Section 1: THE VILLAGE OF BUCKEYE LAKE WILL FURTHER EMPLOY AGGRESSIVE STRATEGIES WHEN A WORK-RELATED INJURY MIGHT UNFORTUNATELY OCCUR TO FULLY INVESTIGATE THE ROOT CAUSE AND TO IDENTIFY THE APPROPRIATE CORRECTIVE MEASURES. THE VILLAGE OF BUCKEYE LAKE WILL ALSO ENSURE THAT ANY WORK-RELATED INJURY RECEIVES PROMPT AND APPROPRIATE MEDICAL TREATMENT, TO INCLUDE AN EMPLOYEE RECOVERY PLAN THAT WILL ENABLE THE EMPLOYEE TO SAFELY RETURN TO WORK AS SOON AS POSSIBLE.

**EMS CONTRACT FOR THE VILLAGE OF BUCKEYE LAKE
BETWEEN THE LICKING TOWNSHIP TRUSTEES AND THE
VILLAGE OF BUCKEYE LAKE**

THIS AGREEMENT, made and entered into this January 1, 2010 by and between the Licking Township Board of Trustees, Licking County, Ohio acting for Licking Township and all residents therein, hereinafter referred to and called "the Board" and the Village of Buckeye Lake, Licking County, Ohio, hereinafter referred to and called "the Village."

WHEREAS, the Board is desirous of providing emergency medical protection for Maple Bay and Hunts Landing area residents of Licking Township, Licking County, Ohio; and,

WHEREAS, the Village has, by Resolution, authorized the execution of the within Contract; and,

WHEREAS, the Board has duly authorized the execution of the within Contract by appropriation resolution:

NOW THEREFORE, it is hereby mutually agreed as follows:

EMERGENCY MEDICAL PROTECTION:

The Board shall pay to the Village the sum of Three hundred Fifty Dollars (\$350 per run) not to exceed Three Thousand Five Hundred Dollars (\$3500 for the calendar year 2010) less the deductions payable to the Fiscal Officer of Licking Township as provided by law. Payment shall be made by the Board during the year based upon the receipt of the Board of taxes collected for the purpose of fire and emergency medical protection in Licking Township and from any balance on hand from monies collected in prior years for fire and medical protection. The Village agrees with the Board to furnish emergency equipment and apparatus, to provide emergency medical services and to protect all residents and property in the Maple Bay and Hunts Landing areas of Licking Township, Licking County, Ohio, which areas are more fully described on the map, which is attached hereto and labeled as "Exhibit A."

It is mutually agreed that this contract shall be effective for a period of one (1) year, commencing January 1st, 2010 and continuing through December 31st, 2010.

It is further agreed that the Village shall hold harmless and indemnify the Board from any and all liability, claims, losses, or damages arising out of the Village's performance of its duties under this contract. The Village agrees to abide by all laws, rules and regulations of the State of Ohio, and to further provide and maintain adequate insurance to save the Board harmless from all claims and demands arising out of the performance of this Contract and shall provide that the Township is a named insured there under. The Village shall provide a copy of said insurance policy together with its declaration page to the Board.

This Contract may be terminated by either party upon the giving on thirty (30) days written notice by certified mail, return receipt requested. If this contract id terminated, then the yearly payment herein provided for the Village emergency medical protection services shall be prorated as to the effective date of cancellation.

This Contract represents the entire agreement of the parties.


