

VILLAGE OF BUCKEYE LAKE, OHIO

RESOLUTION 2019-03

A RESOLUTION AUTHORIZING THE MAYOR AND CLERK TO PLACE A RENEWAL GENERAL FUND LEVY IN EXCESS OF THE TEN (10) MILL LIMITATION ON THE BALLOT AND DECLARING AN EMERGENCY

WHEREAS, the amount of taxes currently raised within the ten (10) mill limitation will be insufficient to provide for current expenses which include street lights within the Village of Buckeye Lake, Ohio;

THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE AUTHORITY OF THE VILLAGE OF BUCKEYE LAKE THAT FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST TWO-THIRDS (2/3) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER TO READ A RESOLUTION ON THREE SEPARATE DAYS,

SECTION I: Council determines and declares that it is necessary to place, for five (5) years, a renewal 1-mill operating levy, which rate equals 1-mill for each dollar of valuation which amounts to .10 cents (\$0.10) for each one hundred dollars of valuation for the benefit of the General Fund of the Village of Buckeye Lake which will include street lights.

SECTION II: Authorization for placement of said levy on the May 7, 2019 ballot before the electorate of the Village of Buckeye Lake is contained in Ohio Revised Code Section 5705.03 in the Village of Buckeye Lake.

SECTION III: Said levy shall be placed upon the tax list for the 2019 tax year in compliance with the provisions of Ohio Revised Code 5705.19, if a majority of the electors therein vote in favor thereof; and be it further resolved that the Clerk of the Village of Buckeye Lake, be and is directed to certify a copy of this resolution to the Board of Elections of Licking and Fairfield County, Ohio, not later than February 6, 2019, the date fixed by law for certifying said resolution relative to a levy in excess of the ten (10) mill limitation and notify said Board of Elections to cause notice of the election on the question of levying said tax to be given as required by law, to be voted on at the May 7, 2019 election.

SECTION IV: The Licking County Auditor and the Fairfield County Auditor have certified the revenue to be produced by this levy during the period in which it is to be collected in the certification attached hereto and made a part hereof and marked Exhibit "A".

SECTION V: Pursuant to Ohio Revised Code § 5705.19 this resolution shall go into immediate effect upon its passage, and no publication of the resolution is necessary other than that provided for in the notice of election.

SECTION VI: This Resolution is hereby declared to be an emergency necessary for the immediate preservation of the public health, safety and welfare. The reason for such necessity is that this Resolution must be enacted immediately to satisfy the filing deadlines to place this issue on the May 7, 2019 ballot. Therefore, this Resolution shall go into immediate effect.
