RESOLUTION NUMBER 2019-10

A RESOLUTION AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE A CONTRACT AND ALL NECESSARY SUPPORTING DOCUMENTS TO PURCHASE A NEW FULLY-EQUIPPED PATROL VEHICLE FOR THE POLICE DEPARTMENT THROUGH THE STATE OF OHIO COMPETITIVE PURCHASING PROGRAM

WHEREAS, the Village of Buckeye Lake Police Department works hard to provide comprehensive, efficient and effective service to the residents of the Village; and

WHEREAS, the Village of Buckeye Lake Police Department is in great need of adding a new patrol cruiser to its current fleet; and

WHEREAS, the Village of Buckeye Lake Police Department desires to purchase one (1) 2019 Ford Explorer SW patrol cruiser for use by the Police Department; and

WHEREAS, this patrol cruiser will be purchased through the State of Ohio Competitive Purchasing Program.

NOW THEREFORE, BE IT RESOLVED by the Village of Buckeye Lake, Ohio, that:

SECTION I: The Mayor is hereby authorized and directed to execute a contract to purchase a fully-equipped 2019 Ford Explorer SW patrol cruiser, from State Wide Auto through the State of Ohio Competitive Purchasing Program, for an amount not to exceed Thirty-Nine Thousand, Four Hundred Ninety-Three Dollars and No Cents (\$39,493.00).

SECTION II: The Mayor is further authorized and directed to execute all loan documents necessary to facilitate purchasing the above-described patrol cruiser on behalf of the Village with North Valley Bank, through Loan Number 496100 dated March 26, 2019.

SECTION III: It is hereby found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of Council and that all deliberations of the Council and any of the decision making bodies of the Village of Buckeye Lake which resulted in such formal actions were in meetings open to the public in compliance with all legal requirements of the State of Ohio.

SECTION IV: This Resolution shall take effect at the earliest time allowed by law.
