

## NOTICE TO BIDDERS

Sealed bids for the Village of Buckeye Lake, Highland Avenue Drainage Improvements project will be received at the Buckeye Lake Village Hall located at 5192 Walnut Road SE, Buckeye Lake, Ohio 43008 until 10:00 AM local time, August 22, 2019, and then at 10:01 AM local time, August 22, 2019 at said office opened and read aloud. Plans, specifications, and bid forms may be secured from ARC for a non-refundable fee of Fifty Dollars (\$50.00). Prospective bidders may secure the plans, specifications and bid forms by emailing [columbus.digital@e-arc.com](mailto:columbus.digital@e-arc.com) with the subject line "Buckeye Lake Highland Avenue Drainage Improvements". Each bidder should include their company name, address and contact information in the body of the email. Alternately, bidders may call (614) 224-5149 and ask to speak with Brent Witzel.

Each bidder is required to furnish with its proposal, a Bid Guaranty and Contract Bond in accordance with Section 153.54 of the Ohio Revised Code. Bid security furnished in Bond form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. The owner intends and requires that this project be completed and ready for final payment no later than December 31, 2019.

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio Products, materials, services, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.

Bidders must comply with the prevailing wage rates on Public Improvements in Licking and the Village of Buckeye Lake as determined by the Ohio Bureau of Employment Services, Wage and Hour Division, (614) 644-2239.

Portions of the work shall be governed by Village of Buckeye and ODOT Specifications, latest edition.

**Domestic steel use requirements as specified in section 153.011 of the Ohio Revised Code apply to this project. Copies of section 153.011 of the Revised Code can be obtained from any of the offices of the department of administrative services.**

This project consists of approximately 1,276 LF of 12" and 24" storm sewer improvements.

conference: however, non-attendance at pre-bid conference does not preclude Contractor from submitting bid.
