

ORDINANCE NUMBER 2019-32

VILLAGE OF BUCKEYE LAKE, OHIO

AN ORDINANCE AWARDING THE BID FOR THE 2019 BUCKEYE LAKE TRENCH LINE REPAIR TO LAW GENERAL CONTRACTING, INC. AND AUTHORIZING AND DIRECTING THE MAYOR TO EXECUTE THE AGREEMENT BETWEEN THE VILLAGE AND SAID CONTRACTOR CONSISTENT WITH SAID BID, AND DECLARING AN EMERGENCY.

WHEREAS, the Village of Buckeye Lake has received bids on July 19, 2019 for what has been termed as 2019 Trench Repair Project; and

WHEREAS, funding has been appropriated with 2019 permanent budget;

NOW, WHEREFORE, Be It Ordained by the Council of the Village of Buckeye Lake, State of Ohio:

SECTION I: That the bid of Law General Contracting, INC. for 2019 trench repair project is hereby APPROVED, and the project is hereby awarded to said successful bidder.

SECTION II: That the mayor be, and hereby is, directed to execute said agreement with Law General Contracting, INC., consistent with the bid awarded herein.

SECTION III: That the bid and agreement are to be for the lump sum amount of \$94,700.00.

SECTION IV: That this ordinance is hereby declared to be an emergency necessary for the public health safety and welfare, such emergency arising from the expiration date of the bids involved, and therefore, shall take effect and be in force from and after its adoption by council and approved by the mayor.
