ORDINANCE NUMBER 2019-42

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO CONTRACT WITH OHIO ROW CONSULTING FOR MANAGEMENT OF THE VILLAGE OF BUCKEYE LAKE RIGHT-OF-WAY PROGRAM.

WHEREAS, Village Council has created a Right-of-Way (ROW) program; and

WHEREAS, it is necessary to update and manage the program on a regular basis; and

WHEREAS, the Mayor and Council have created such rules and regulations necessary for the regulating of the public right-of-ways; and

WHEREAS, the village feels that it is most efficient to have the program managed by a third party.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, LICKING COUNTY, STATE OF OHIO, that

SECTION I: That the Mayor is hereby authorized and directed to enter into an agreement with the Ohio RoW Consulting as outlined in the attached Exhibit "A" 2020 Contractor agreement, which is hereby incorporated by reference, to the Village of Buckeye Lake, Ohio.

SECTION II: The Village Mayor will sign the contractor agreement following the effective date of this ordinance.

SECTION III: This ordinance shall take effect and be in force at the earliest date allowed by law.
