ORDINANCE 2020-08

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO CONTRACT MODIFICATION WITH ADR & AND ASSOCIATES, LTD FOR PROJECT CONSTRUCTION PROCESS FOR THE REPLACEMENT OF DEFICIENT STRUCTURE AND SIDEWALKS IDENTIFIED AS LIC-SR79-3.98 (PID #108770), AND DECLARING AN EMERGENCY

WHEREAS, engineering services for phase II including completion of environmental documentation and construction contract plans are need to complete project.

WHEREAS, the Village of Buckeye Lake has accepted the proposed terms at ODOT recommendations;

WHEREAS, the Village of Buckeye Lake is required to enter into a agreement modification with ADR & Associates, LTD for Development work; and

THEREFORE, FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST TWO THIRDS (2/3) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER SECTION 4.04 TO READ AN ORDINANCE ON THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN READINGS

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, LICKING COUNTY, STATE OF OHIO, that

SECTION I: That the Mayor is hereby authorized and directed to enter into an modification agreement with ADR & Associates, LTD as outlined in the attached Exhibit "A".

SECTION II: The Village Mayor shall sign agreement No. 33103-2 following the effective date of this ordinance.

SECTION III: That this Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health, safety, thereof, for the reason that it is immediately necessary to contract consulting services for advice in a rapidly changing and developing technical area, and provided it receives the necessary affirmative votes as required by the passage and approval by the Village of Buckeye Lake Council; otherwise it shall take effect and be in force at the earliest period allowed by law.
