VILLAGE OF BUCKEYE LAKE, OHIO

A RESOLUTION AMENDING RULES AND REGULATIONS FOR THE VILLAGE OF BUCKEYE LAKE WATER DEPARTMENT, AND DECLARING AN EMERGENCY

WHEREAS, The Village of Buckeye Lake operates and maintains a water distribution system; and

WHEREAS, the Village of Buckeye Lake considers the safety and security of their residents to extremely important; and

WHEREAS, placing water rules and regulations in effect will create a standard guideline for the water department to follow in their daily operations, and

WHEREAS, the Village of Buckeye Lake feels the need to amend rules and regulation to allow for emergency measures to be enacted to the water billing rules and regulation during times of State of Emergency's, that are in the best interest of customers.

THEREFORE, BE IT RESOLVED BY THE LEGISLATIVE AUTHORITY OF THE VILLAGE OF BUCKEYE LAKE THAT FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST TWO-THIRDS (2/3) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER TO READ A RESOLUTION ON THREE SEPARATE DAYS,

NOW THEREFORE, BE IT RESOLVED by the Village of Buckeye Lake, Ohio:

SECTION I: That the Village of Buckeye Lake hereby amends Rule 17 of the Village of Buckeye Lake Water Department Rules and Regulations.

SECTION II: Rule 17 RIGHT TO ALTER OR AMEND RULES AND REGULATIONS: Shall read as follows:

“The Village hereby reserves the right to add to or amend any or all conditions covering water service provided upon 30 days’ notice. Exception to the 30 days’ notice shall be waived if the proposed change or addition is in response to declared State of Emergency and the proposed change or addition is in the best interest of the customers.”

SECTION III: That this Resolution shall take effect and be in force from and after the earliest period allowed by law.
