

# 1981 ORDINANCES

- 1981-01** AN ORDINANCE GIVING CONSENT OF THE VILLAGE TO THE PLOWING OF SNOW AND USE OF ABRASIVES FOR ICE CONTROL UNDER THE SUPERVISION OF THE DIRECTOR OF HIGHWAYS, STATE OF OHIO.
- 1981-02** AN ORDINANCE GRANTING DIRECTOR OF HIGHWAYS AUTHORITY TO MAINTAIN STATE HIGHWAYS INSIDE VILLAGE CORPORATION.
- 1981-03** AN ORDINANCE GRANTING DIRECTOR OF HIGHWAYS AUTHORITY TO MAINTAIN CENTERLINES ON STATE HIGHWAYS INSIDE VILLAGE CORPORATION.
- 1981-04** AN ORDINANCE DIRECTING THE CLERK OF THE VILLAGE TO POST COPIES OF ALL ORDINANCES; RESOLUTIONS, STATEMENTS, ORDERS, PROCLAMATIONS, NOTICES, AND REPORTS IN FIVE OF THE MOST PUBLIC PLACES IN THE MUNICIPAL CORPORATION, AND DECLARING AN EMERGENCY.
- 1981-05** AN ORDINANCE DIRECTING THE LAW DIRECTOR TO PREPARE BONDS OF THE OFFICERS OF THE VILLAGE OF BUCKEYE LAKE, STATE OF OHIO, AND ESTABLISHING THE SUM OF BOND FOR THE VILLAGE OF BUCKEYE LAKE'S OFFICERS, AND DECLARING AN EMERGENCY.
- 1981-06** AN ORDINANCE ESTABLISHING AN EXCISE TAX ON TRANSACTIONS BY WHICH LODGING BY A HOTEL IS OR IS TO BE FURNISHED TO TRANSIENT GUESTS.
- 1981-07** AN EMERGENCY ORDINANCE ENACTED BY THE VILLAGE OF BUCKEYE LAKE, LICKING COUNTY, OHIO, IN THE MATTER OF THE HEREINAFTER DESCRIBED IMPROVEMENT (BUILDING A SANITARY SEWER), UNDER THE SUPERVISION OF THE DIRECTOR OF TRANSPORTATION.
- 1981-08** AN ORDINANCE ESTABLISHING RULES OF GOVERNMENT FOR THE VILLAGE OF BUCKEYE LAKE, OHIO, AND DECLARING AN EMERGENCY.
- 1981-09** AN ORDINANCE TO SET THE FOLLOWING CURFEW FOR CHILDREN IN THE INCORPORATED AREAS OF THE VILLAGE OF BUCKEYE LAKE, OHIO.

- 1981-10** AN ORDINANCE ESTABLISHING THE COMPENSATION OF THE ELECTED OFFICIALS OF THE VILLAGE OF BUCKEYE LAKE, MAKING THE PROVISION HEREOF RETROACTIVE.
- 1981-11** AN ORDINANCE GRANTING TO OHIO POWER COMPANY , ITS SUCCESSORS AND ASSIGNS, THE RIGHT TO ACQUIRE, CONSTRUCT, MAINTAIN, AND OPERATE IN THE STREETS, THOROUGHFARES, ALLEYS, BRIDGES, AND PUBLIC PLACES OF THE VILLAGE OF BUCKEYE LAKE, STATE OF OHIO, AND ITS SUCCESSORS, LINES FOR THE DISTRIBUTION OF ELECTRIC ENERGY TO THE VILLAGE OF BUCKEYE LAKE, AND THE INHABITANTS THEREOF FOR LIGHT, HEAT, POWER, AND OTHER PURPOSES, AND FOR THE TRANSMISSION OF THE SAME WITHIN, THROUGH, OR ACROSS SAID VILLAGE OF BUCKEYE LAKE, STATE OF OHIO.
- 1981-12** AN ORDINANCE PROHIBITING OPEN BURNING WITHIN THE VILLAGE OF BUCKEYE LAKE, OHIO, CREATING CERTAIN EXCEPTIONS AND DECLARING AN EMERGENCY.
- 1981-13** AN ORDINANCE ADOPTING THE BOCA BASIC FIRE PREVENTION CODE OF 1981 AS AMENDED.
- 1981-14** AN ORDINANCE TO COMBINE THE DUTIES OF THE CLERK AND TREASURER OF THE VILLAGE OF BUCKEYE LAKE, OHIO, AND NAMING SAME OFFICE, CLERK / TREASURER.
- 1981-15** AN ORDINANCE ADOPTING THE BOCA BASIC PROPERTY MAINTENANCE CODE 1981, SECOND EDITION, AS AMENDED.
- 1981-16** AN ORDINANCE GRANTING A NON-EXCLUSIVE FRANCHISE TO TOWER CABLE TO OPERATE AND MAINTAIN A CABLE TELEVISION SYSTEM IN THE VILLAGE OF BUCKEYE LAKE, OHIO, SETTING FORTH THE TERMS AND CONDITIONS ACCOMPANYING THE GRANT OF THE FRANCHISE AND PROVIDING FOR REGULATION OF THE CABLE TELEVISION SYSTEM.
- 1981-17** AN ORDINANCE CREATING A STREET DEPARTMENT FOR THE VILLAGE OF BUCKEYE LAKE, OHIO.
- 1981-18** AN ORDINANCE AMENDING ORDINANCE NUMBER 81-10 RELATING TO THE SALARIES PAID TO CERTAIN ELECTED OFFICIALS IN THE VILLAGE OF BUCKEYE LAKE, OHIO.
- 1981-19** AN ORDINANCE ESTABLISHING THE POSITIONS OF ASSISTANT FIRE PREVENTION OFFICERS FOR THE VILLAGE OF BUCKEYE LAKE, OHIO.

- 1981-20** AN ORDINANCE CREATING THE BUCKEYE LAKE VILLAGE PLANNING COMMISSION AND APPOINTING CERTAIN INDIVIDUALS TO TERMS ON THAT COMMISSION.
- 1981-21** AN ORDINANCE AMENDING ORDINANCE NUMBER 81-9, CREATING CRIMINAL PENALTIES FOR PERSONS WHO PERMIT CHILDREN UNDER THEIR CARE, CUSTODY AND CONTROL TO VIOLATE THE CURFEW OF THE VILLAGE OF BUCKEYE LAKE, OHIO.
- 1981-22** AN ORDINANCE AUTHORIZING THE MAYOR AND THE CLERK TO ENTER INTO CONTRACT WITH A MAXIMUM OF FIVE INDIVIDUALS TO WORK ON A CONTRACTUAL BASIS IN THE STREET DEPARTMENT WHEN IN THE OPINION OF THE MAYOR THEY ARE NEEDED.
- 1981-23** AN EMERGENCY ORDINANCE ENACTED BY THE VILLAGE OF BUCKEYE LAKE, LICKING COUNTY, OHIO, IN THE MATTER OF THE HEREINAFTER DESCRIBED IMPROVEMENT (APPLYING AN ASPHALT CONCRETE SURFACE COURSE TO SR 79 WITHIN THE CORPORATE LIMITS OF THE VILLAGE), UNDER THE SUPERVISION OF THE DIRECTOR OF TRANSPORTATION.
- 1981-24** AN ORDINANCE ADOPTING A TRAFFIC AND GENERAL OFFENSE CODE FOR THE VILLAGE OF BUCKEYE LAKE, OHIO AND DECLARING AN EMERGENCY.
- 1981-25** AN ORDINANCE ESTABLISHING A PURCHASING PROCEDURE FOR THE VILLAGE OF BUCKEYE LAKE, OHIO.
- 1981-26** AN ORDINANCE DIRECTING THE LAW DIRECTOR TO PREPARE BONDS OF THE OFFICIALS OF THE VILLAGE OF BUCKEYE LAKE, STATE OF OHIO, AND ESTABLISHING THE SUM OF BOND FOR THE VILLAGE OF BUCKEYE LAKE'S OFFICIALS, AND DECLARING AN EMERGENCY.
- 1981-27** AN ORDINANCE AMENDING ORDINANCE NUMBER 81-8.
