- 1985-01** AN ORDINANCE EXPANDING THE NUMBER OF AUXILIARY OFFICERS WITHIN THE BUCKEYE LAKE VILLAGE POLICE DEPARTMENT.
- 1985-02** ANNUAL APPROPRIATIONS ORDINANCE.
- 1985-03** AN EMERGENCY ORDINANCE ENACTED BY THE VILLAGE OF BUCKEYE LAKE, LICKING COUNTY, OHIO, IN THE MATTER OF THE HEREINAFTER DESCRIBED IMPROVEMENT, AND TO REQUEST COOPERATION FROM THE DIRECTOR OF TRANSPORTATION FOR A BRIDGE REPLACEMENT PROJECT.
- 1985-04** AN ORDINANCE AMENDING ORDINANCE 1985-02, THE VILLAGE ANNUAL APPROPRIATION ORDINANCE.
- 1985-05** AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$30,000 OF NOTES BY THE VILLAGE OF BUCKEYE LAKE, OHIO, IN ANTICIPATION OF THE ISSUANCE OF BONDS FOR THE PURPOSE OF PAYING PART OF THE COST OF ACQUIRING A BUILDING WHICH WILL BE USED FOR MUNICIPAL OFFICES IN THE VILLAGE, AND DECLARING AN EMERGENCY.
- 1985-06** AN ORDINANCE AUTHORIZING AND DIRECTING THE LITTER GRANT SUPERVISOR TO ACT AS ENFORCEMENT OFFICER CONCERNING THE PROPERTY MAINTENANCE CODE OF THE VILLAGE OF BUCKEYE LAKE, OHIO AND DECLARING AN EMERGENCY.
- 1985-07** AN EMERGENCY ORDINANCE ENACTED BY THE VILLAGE OF BUCKEYE LAKE, LICKING COUNTY, OHIO, IN THE MATTER OF THE HEREINAFTER DESCRIBED IMPROVEMENT, AND TO REQUEST COOPERATION FROM THE DIRECTOR OF TRANSPORTATION FOR A HAZARD ELIMINATION PROJECT.
- 1985-08** **CANCELLED BY COUNCIL** - LEVYING A TAX TO PROVIDE FUNDS FOR THE PURPOSES OF GENERAL MUNICIPAL OPERATION, MAINTENANCE OF EQUIPMENT, EXTENSION, ENLARGEMENT AND IMPROVEMENT OF MUNICIPAL SERVICES AND FACILITIES AND CAPITAL IMPROVEMENTS, ON ALL SALARIES, WAGES, COMMISSIONS AND OTHER COMPENSATIONS EARNED BY RESIDENTS OF THIS MUNICIPALITY; ON ALL SALARIES, WAGES, COMMISSIONS AND OTHER COMPENSATION EARNED BY NONRESIDENTS OF THIS MUNICIPALITY; FOR WORK DONE OR SERVICES PERFORMED OR RENDERED IN THIS MUNICIPALITY; ON THE NET PROFITS EARNED ON ALL BUSINESSES, PROFESSIONS OR

OTHER ACTIVITIES CONDUCTED BY RESIDENTS OF THIS MUNICIPALITY; ON THE NET PROFITS EARNED ON ALL BUSINESSES, PROFESSIONS OR OTHER ACTIVITIES CONDUCTED IN THIS MUNICIPALITY BY NONRESIDENTS, AND ON THE NET PROFITS EARNED BY ALL CORPORATIONS DOING BUSINESS IN THIS MUNICIPALITY AS A RESULT OF WORK DONE OR SERVICES PERFORMED OR RENDERED IN THIS MUNICIPALITY; REQUIRING THE FILING OF RETURNS AND FURNISHING OF INFORMATION BY EMPLOYERS AND ALL THOSE SUBJECT TO SAID TAX; IMPOSING ON EMPLOYERS THE DUTY OF COLLECTING THE TAX AT THE SOURCE AND PAYING THE SAME TO THIS MUNICIPALITY; APPROPRIATING THE PROCEEDS THEREFROM; PROVIDING FOR THE ADMINISTRATION, COLLECTION AND ENFORCEMENT OF SAID TAX; DECLARING VIOLATION THEREOF TO BE A MISDEMEANOR AND IMPOSING PENALTIES THEREFOR; AND DECLARING AN EMERGENCY.

- 1985-09** AN ORDINANCE CHANGING THE PROCEDURE FOR PAYMENT OF VILLAGE COUNCIL MEMBERS.
- 1985-10** AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$100,000 OF NOTES BY THE VILLAGE OF BUCKEYE LAKE, OHIO, IN ANTICIPATION OF THE ISSUANCE OF BONDS FOR THE PURPOSE OF PAYING PART OF THE COST OF ACQUIRING A BUILDING WHICH WILL BE USED FOR MUNICIPAL OFFICES IN THE VILLAGE, AND DECLARING AN EMERGENCY.
- 1985-11** AN ORDINANCE CORRECTING A LEGISLATIVE OVERSIGHT REGARDING THE SALARY OF THE CLERK/TREASURER OF THE VILLAGE OF BUCKEYE LAKE, OHIO.
