

1991 ORDINANCES

- 1991-01** AN ORDINANCE TO AWARD CONTRACT FOR EMERGENCY SQUAD SERVICES WITHOUT COMPETITIVE BIDDING AND TO DECLARE AN EMERGENCY.
- 1991-02** ANNUAL APPROPRIATION ORDINANCE.
- 1991-03** AN ORDINANCE TO ADOPT THE 1991 REPLACEMENT PAGES FOR THE MODEL OHIO MUNICIPAL CODE PUBLISHED BY THE JUSTINIAN PUBLISHING COMPANY; TO REPEAL ORDINANCES IN CONFLICT THEREWITH AND TO DECLARE AN EMERGENCY.
- 1991-04** AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR TO ENTER INTO A CONTRACT WITH THE BOARD OF COUNTY COMMISSIONERS OF LICKING COUNTY TO PURCHASE EQUIPMENT ON BEHALF OF THE BUCKEYE LAKE VILLAGE FIRE DEPARTMENT.
- 1991-05** AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$13,000 OF NOTES BY THE VILLAGE OF BUCKEYE LAKE, OHIO, IN ANTICIPATION OF THE ISSUANCE OF BONDS FOR THE PURPOSE OF PAYING PART OF THE COST OF ACQUIRING A BUILDING WHICH WILL BE USED FOR MUNICIPAL OFFICES IN THE VILLAGE, AND DECLARING AN EMERGENCY.
- 1991-06** AN ORDINANCE AMENDING ORDINANCE 90 - 04 BY CHANGING THE LOCATION OF PUBLIC POSTING PLACES WITHIN THE VILLAGE OF BUCKEYE LAKE, OHIO.
- 1991-07** AN ORDINANCE DECLARING SEYMOUR AVENUE WITHIN THE VILLAGE OF BUCKEYE LAKE, OHIO TO BE A ONE-WAY STREET.
- 1991-08** VILLAGE TAX BUDGET ORDINANCE.
- 1991-09** AN ORDINANCE TO PROVIDE FOR SUBMITTING TO THE ELECTORS OF BUCKEYE LAKE, OHIO, AT THE NEXT REGULAR ELECTION, THE QUESTION, "SHALL A COMMISSIONER BE CHOSEN TO FRAME A CHARTER?", APPROPRIATING FUNDS THEREFOR AND DECLARING AN EMERGENCY.
- 1991-10** AN ORDINANCE AUTHORIZING AND DIRECTING THE MAYOR AND/OR OTHER APPROPRIATE OFFICIAL TO PUBLISH NOTICE FOR COMPETITIVE BIDDING AND TO ENTER INTO A CONTRACT BASED ON THE COMPETITIVE BIDDING FOR REAL PROPERTY AND DECLARING AN EMERGENCY.

- 1991-11** AN ORDINANCE AMENDING THE PROPERTY MAINTENANCE CODE OF THE VILLAGE OF BUCKEYE LAKE, OHIO, (ORDINANCE 81-15 AND AMENDMENTS THERETO) BY MODIFYING EXISTING CODE SECTION AND DECLARING AN EMERGENCY.
- 1991-12** AN ORDINANCE AUTHORIZING THE CONVEYANCE OF CERTAIN REAL PROPERTY WITHIN THE VILLAGE OF BUCKEYE LAKE, LICKING COUNTY, OHIO.
- 1991-13** AN ORDINANCE PROVIDING FOR THE ISSUANCE OF \$57,000 OF NOTES BY THE VILLAGE OF BUCKEYE LAKE, OHIO, IN ANTICIPATION OF THE ISSUANCE OF BONDS FOR THE PURPOSE OF PAYING PART OF THE COST OF ACQUIRING A BUILDING WHICH WILL BE USED FOR MUNICIPAL OFFICES FOR THE VILLAGE, AND DECLARING AN EMERGENCY.
- 1991-14** AN ORDINANCE FIXING AND REGULATING THE PRICE THAT MAY BE CHARGED BY NATIONAL GAS & OIL CORPORATION, ITS SUCCESSORS OR ASSIGNS, FOR GAS SERVICE TO THE VILLAGE OF BUCKEYE LAKE, OHIO, AND TO ITS INHABITANTS, FOR THE PERIOD OF TWO (2) YEARS FROM AND AFTER THE EFFECTIVE DATE OF THIS ORDINANCE; AND REPEALING ORDINANCE NO. 87-09.
- 1991-15** GRANTING DIRECTOR OF TRANSPORTATION AUTHORITY TO MAINTAIN STATE HIGHWAYS, APPLY STANDARD LONGITUDINAL PAVEMENT MARKINGS AND ERECT REGULATORY AND WARNING SIGNS ON STATE HIGHWAYS INSIDE VILLAGE CORPORATION. GIVING CONSENT OF THE VILLAGE TO THE PLOWING OF SNOW AND USE OF ABRASIVES FOR ICE CONTROL UNDER THE SUPERVISION OF THE DIRECTOR OF TRANSPORTATION, STATE OF OHIO.
