- 2005-01** TEMPORARY APPROPRIATION ORDINANCE AND DECLARATION OF EMERGENCY.
- 2005-02** AMENDING ORDINANCE 2005-01 “TEMPORARY APPROPRIATION ORDINANCE” AND DECLARATION OF EMERGENCY.
- 2005-03** AN ORDINANCE RESCINDING ORDINANCE 2004-15 AND AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH WATER’S EDGE MINISTRY FOR THE LEASE OF PROPERTY LOCATED AT 5196 WALNUT ROAD, BUCKEYE LAKE, OHIO 43008 AND DECLARING AN EMERGENCY.
- 2005-04** AN ORDINANCE TO HIRE A CLERK OF COUNCIL, FIX THE HOURS AND COMPENSATION THEREFORE AND DECLARE AN EMERGENCY.
- 2005-05** PERMANENT APPROPRIATIONS ORDINANCE AND DECLARATION OF EMERGENCY.
- 2005-06** AMENDING ORDINANCE 2005-05 “PERMANENT APPROPRIATIONS ORDINANCE” AND DECLARATION OF EMERGENCY.
- 2005-07** AN ORDINANCE AUTHORIZING THE MAYOR TO NEGOTIATE AND ENTER INTO A CONTRACT WITH ABLE ROOFING FOR THE REPLACEMENT OF THE “DRIVE THROUGH” ROOF.
- 2005-08** AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH JJTM HOLDINGS, LLC DOING BUSINESS AS LAKE DRIVE-THRU (“LESSEE”) FOR THE LEASE OF PROPERTY LOCATED AT 5186 WALNUT ROAD, BUCKEYE LAKE, OHIO 43008 AND DECLARING AN EMERGENCY.
- 2005-09** AN ORDINANCE AUTHORIZING THE SUBLEASE OF THE PROPERTY LOCATED AT 41 1ST STREET, BUCKEYE LAKE, OHIO 43008 AND DECLARING AN EMERGENCY.
- 2005-10** AN ORDINANCE CONSENTING TO AN EXPEDITED TYPE II ANNEXATION OF APPROXIMATELY 8 ACRES LOCATED ON STATE ROUTE 360, CURRENTLY IN WALNUT TOWNSHIP; AND DECLARING AN EMERGENCY.

- 2005-11** AN ORDINANCE AUTHORIZING THE MAYOR TO EXCHANGE LAND WITH CHARLES WILLIAM BOSTWICK FOR THE BENEFIT OF ADDITIONAL ROAD FRONTAGE.
- 2005-12** AN ORDINANCE ADOPTING THE RESIDENTIAL CODE OF OHIO FOR ONE, TWO, AND THREE FAMILY DWELLINGS (EDITION) (AKA OBOA).
- 2005-13** AN ORDINANCE AUTHORIZING THE MAYOR TO NEGOTIATE AND ENTER INTO A BIKE/SKATE PARK HARD SURFACE ENGINEERING AGREEMENT WITH JOBES HENDERSON & ASSOCIATES, INC. AND DECLARING AN EMERGENCY.
- 2005-14** AN ORDINANCE AUTHORIZING THE MAYOR TO NEGOTIATE AND ENTER INTO A CONTRACT WITH BRENT ENTERPRISES FOR THE REPLACEMENT OF THE FIRE DEPARTMENT CONCRETE APPROACH AND DECLARING AN EMERGENCY.
- 2005-15** AN ORDINANCE AUTHORIZING THE MAYOR TO EXECUTE ANY AND ALL DOCUMENTATION TO ALLOW THE VILLAGE OF BUCKEYE LAKE TO BORROW UP TO \$175,000.00 FOR THE REPAYMENT OF THE OHIO WATER DEVELOPMENT AUTHORITY (OWDA) LOAN AND DECLARING AN EMERGENCY.
- 2005-16** AMENDING ORDINANCE 2005-05 "PERMANENT APPROPRIATIONS ORDINANCE" AND DECLARATION OF EMERGENCY.
- 2005-17** AN ORDINANCE ADOPTING NEW POLICY FOR THE USE OF VILLAGE OWNED CELLULAR PHONES BY AN EMPLOYEE OF THE VILLAGE OF BUCKEYE LAKE OHIO.
- 2005-18** AN ORDINANCE ADOPTING NEW POLICY FOR THE USE OF VILLAGE OWNED PURCHASING CARDS BY AN EMPLOYEE OR ELECTED OFFICIAL OF THE VILLAGE OF BUCKEYE LAKE OHIO.
- 2005-19** AN ORDINANCE PROVIDING FOR THE ISSUANCE AND SALE OF \$175,000 BONDS FOR THE PURPOSE OF REFUNDING THE OUTSTANDING PRINCIPAL AMOUNT OF A LOAN FROM THE OHIO WATER DEVELOPMENT AUTHORITY THE PROCEEDS OF WHICH WERE USED TO PAY A PORTION OF THE COSTS OF THE VILLAGE'S WATER SYSTEM, PAYING CERTAIN FINANCING COSTS OF THE BONDS, AND DECLARING AN EMERGENCY.
- 2005-20** AN ORDINANCE AUTHORIZING THE MAYOR TO NEGOTIATE AND ENTER INTO A CONTRACT WITH FIVE STAR ROOFING FOR THE REPLACEMENT OF THE "DRIVE THROUGH" ROOF, AND DECLARING AN EMERGENCY.

- 2005-21** AN ORDINANCE DECLARING THE NECESSITY TO INSTALL A VILLAGE-WIDE WATER SUPPLY AND DISTRIBUTION SYSTEM, DIRECTING THE PREPARATION OF A TENTATIVE ASSESSMENT AS TO ALL PROPERTIES WITHIN THE VILLAGE AND DECLARAING AN EMERGENCY.
- 2005-22** AN ORDINANCE AMENDING SECTIONS 3.05, 4.05, 4.06 AND 10.02 OF THE CHARTER OF THE VILLAGE OF BUCKEYE LAKE, AND DECLARING AN EMERGENCY.
- 2005-23** AN ORDINANCE ANNEXING CERTAIN TERRITORY, GENERALLY DESCRIBED AS BEING APPROXIMATELY 8 ACRES LOCATED ON STATE ROUTE 360, CURRENTLY IN WALNUT TOWNSHIP.
- 2005-24** **FAILED** - AN ORDINANCE AUTHORIZING AN AGREED UPON 10 PERCENT REDUCTION IN POLICE COMPENSATION.
- 2005-25** AN ORDINANCE TO REPEAL EXISTING ARTICLE 13, TO ESTABLISH NEW ARTICLE 13, REGARDING ADULT ENTERTAINMENT FACILITIES, OF THE BUCKEYE LAKE ZONING CODE, AND DECLARING AN EMERGENCY.
- 2005-26** AN ORDINANCE LEVYING A PRELIMINARY ASSESSMENT FOR A VILLAGE-WIDE WATER SUPPLY AND DISTRIBUTION SYSTEM UPON PROPERTIES DETERMINED BY COUNCIL TO BE BENEFITED, PURSUANT TO R.C. 729.11, AND DECLARING AN EMERGENCY.
- 2005-27** AN ORDINANCE AMENDING ORDINACE 2005-19 PASSED BY THE VILLAGE COUNCIL ON JULY 25, 2005 TO PROVIDE THAT THE VILLAGE'S BOND WILL BE A TERM BOND WITH MANDATORY SINKING FUND REDEMPTION REQUIREMENTS RATHER THAN A SERIAL MATURITY BOND, AND DECLARING AN EMERGENCY.
- 2005-28** AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH AGO PACIFIC CORPORATION, ANDREW HADDAD, PRESIDENT, DOING BUSINESS AS LAKE DRIVE-THRU ("LESSEE") FOR THE LEASE OF PROPERTY LOCATED AT 5186 WALNUT ROAD, BUCKEYE LAKE, OHIO 43008.
- 2005-29** AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH SKIP SALOME ENTERPRIZES, DOING BUSINESS AS LEES FAMOUS RECIPE CHICKEN ("LESSEE") FOR THE LEASE OF PROPERTY LOCATED AT 5204 WALNUT ROAD, BUCKEYE LAKE, OHIO 43008.

- 2005-30** AN ORDINANCE TO AMEND ORDINANCE 96-09 VILLAGE OF BUCKEYE LAKE ZONING ORDINANCE AND DECLARE AN EMERGENCY.
- 2005-31** AN ORDINANCE AMENDING ORDINANCE 2005-19 AND ORDINANCE 2005-27 PASSED BY THE VILLAGE COUNCIL ON JULY 25, 2005 AND ON SEPTEMBER 12, 2005 RESPECTIVELY TO PROVIDE THAT THE VILLAGE'S BOND WILL BE A TERM BOND WITH MANDATORY SINKING FUND REDEMPTION REQUIREMENTS RATHER THAN A SERIAL MATURITY BOND, AUTHORIZING THE EXECUTION OF A CERTIFICATE OF AWARD, DETERMINING CERTAIN OTHER TERMS OF THE BONDS, AND DECLARING AN EMERGENCY.
- 2005-32** AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH JOBES, HENDERSON & ASSOCIATES, INC. FOR ENGINEERING AND ENGINEERING REVIEW SERVICES FOR VILLAGE OF BUCKEYE LAKE PUD DISTRICTS.
- 2005-33** AN ORDINANCE APPROVING, ADOPTING AND ENACTING THE 2005 EDITION OF THE MODEL OHIO MUNICIPAL CODE – ADMINISTRATION CODE, AS REVISED THROUGH NOVEMBER 14, 2004, PUBLISHED BY AMERICAN LEGAL PUBLISHING FOR THE VILLAGE OF BUCKEYE LAKE, OHIO; REPEALING ORDINANCES AND RESOLUTIONS IN CONFLICT THEREWITH; PUBLISHING THE ENACTMENT OF NEW MATTER; AND DECLARING AN EMERGENCY.
- 2005-34** AMENDING PERMANENT APPROPRIATION ORDINANCE 2005- AND DECLARATION OF EMERGENCY.
