UNFINISHED BUSINESS:

Councilor Goodman brought up that it is important that a Charter Commission be developed because the Village is way past due for the Charter to be updated. Councilor Zwissler agrees that it needs to be advertised in the paper. This process takes a few months. The listing is still posted on the office posting board, the posting board at the post office, and on the Village website.

NEW BUSINESS:

Council President Geiger asked if any Council members had feelings about Food Trucks in regards to the Zoning Regulations book. Councilor Lemmon said food trucks should be registered with the Licking County Health Department. Councilor Goodman did some research and mentioned the food trucks should register with the Village office, show proof of insurance, show up-to-date food service license, show most current health department inspection, and the Village would need to decide if there would be a fee and what the fee structure would look like because of the different variables (ex: one-time fee at beginning of year at registration and good for the whole year). Lindsey's Smokehouse Barbecue food truck sits on Mr. Lindsey's property, so how would that be handled fairly? Fire Chief Wyse said they would also need a fire permit. Councilor Goodman also mentioned the potential for a food truck festival at the new Pavilion site. Mayor Wells said she spoke to Bill Collinson (Bike Buckeye Lake) who plans to have the main starting point of the event this year at North Shore Park instead of the Buckeye Lake Winery, so food trucks will most likely be there.

Mayor Wells spoke to Jim Neel who wants to know if the Village is interested in buying the lot south of the Fire Department, and if so, they should make an offer. This was passed over to the Community Development Committee for follow up.

<u>CITIZEN'S COMMENTS</u>: Citizen's comment received from Charlene Hayden of 67 Lighthouse Lane (subject: Council Meeting Information Communication) and read by Councilor Cable. Council President Geiger said there will be a workgroup to explore the options we have for this issue and it will be reported back to Council.

COUNCIL MEMBER COMMENTS:

Councilor Cable: Apologized for being late today due to a family emergency.

<u>Councilor French</u>: Mentioned that the Eagles donated money to the Police and Fire Departments. This will most likely be followed up with a Resolution or thank you note. Councilor French asked President Geiger if the Zoning Regulations book is still at the attorney level. President Geiger said yes, it is still on hold at the attorney level due to the dual zoning issue. A Zoom meeting is being scheduled possibly next Wednesday to look at that.

Councilor Goodman: Glad to hear a workgroup is being put together to address the Citizen's Comments. Councilor Goodman feels the frustration of the citizens because the citizen's letter is read but the issue is not addressed, but looking at a way to address it will be better for the citizens to be able to communicate with Council. Councilor Goodman spoke with the Buckeye Lake Library supervisor today and the library still does not have a date for when they plan to reopen. They are open for pick-ups 2 days a week right now. Buckeye Lake and Utica branches are the only ones that have not reopened as of February 1st. Councilor Goodman encourages residents to contact Babette Wofter at the Licking County Library and let her know how important it is for the library to be open.

<u>Councilor Lemmon:</u> Appreciates how everyone has come together to work on a lot of these projects.

Councilor Zwissler: Licking County Health Department has a call center for the Covid-19 vaccination. Councilor Zwissler says when you get the vaccination, make sure you get a date for your second shot. Make sure you call 740-670-0949 and keep calling if it is busy. Red Cross is having a Blood Drive on Friday, you can call them at 1-800-733-2767 or 740-349-9422. Councilor Zwissler does not like workgroups set up. She thinks it has circumvented the Committee process and she would like the Committee process to stay as it is. Council President Geiger said that the Covid-19 task force was set up because it did not fit into any one Committee. They did not make any decisions; quotes and research was done. Councilor Lemmon suggests that Committees set up the work groups.

Councilor Beard: Thanked Councilor French for his help.

ADJOURNMENT: Motion by Councilor Zwissler to adjourn the meeting and seconded by Councilor Goodman.
