Thomas Wolfe was sworn in to the vacant Council seat by Mayor Peggy Wells. He took the seat for the rest of the Council meeting and was asked to abstain in voting since he has not had time to see the legislation on the meeting's agenda. He will also serve as chair of the Public Safety Committee.

COUNCIL STANDING COMMITTEE REPORTS:

Finance Committee: Had a meeting this evening before the Council meeting and Councilor Lemmon will turn in the minutes for that, as there was a lot talked about. Finance Committee

will have a standing Finance Committee meeting on the fourth Monday of each month at 6:30pm before the regular council meeting.

<u>Public Safety Committee:</u> Councilor French, who was standing in as chair for this committee until the new chair was appointed, will get with newly appointed chair, Tom Wolfe, about police and fire matters.

<u>Public Service Committee:</u> Next Public Service Committee meeting will be August 2, 2021 at 6:30pm.

Rules Committee: Submitted revised Council Rule 41A, which is to be talked about under unfinished business towards the end of the Council meeting agenda this evening.

<u>Community Development Committee</u>: Councilor Zwissler has received complaints from citizens about burglaries and "scary people" around the village. She spoke with Police Chief Harget and they discussed starting a citizen's patrol that could work with police and Public Safety Committee.

<u>Personnel Committee:</u> Personnel Committee met tonight to discuss implementing a step pay chart for the Water Department. Water Tech 1 and Water Tech 2. Toby Miller is in the process of hiring someone for the Water Tech 1 position.

Personnel Committee recommended to Council:

Water Tech 1 \$16 - \$19 / hr Water Tech 2 \$17 - \$20 / hr

Those recommendations were base on a comparative analysis of other neighboring entities to be competitive. The steps will be based on performance reviews, experience, and certifications.

REPORT OF VILLAGE OFFICIALS:

<u>Police Department - Chief Jason Harget</u> – Two new officers have started in the Police Department. \$3,000 worth of equipment was donated from the Bexley Police Department to transform the K-9 cruiser into a regular cruiser with a partition, window guards, and a rear gate. New Officer Johannes Lorenz has experience working on vehicles, so he will install this equipment at no cost to the village.

Fire Department - Chief Ryan Wyse - No report.

Public Works – Toby Miller – No report.

<u>Code Enforcement – Rex Adkins</u> – Continuing enforcement of tall grass and weeds. Lawn mowing service was averaging about ten lawns they had to do each time; it is now down to five. A dozen new properties to address with regards to bad exterior conditions that Rex Adkins is hoping to get taken care of within the next month. One property that has been a problem for a few years is now in Licking County Municipal court.

Parks and Recreation - Kellie Green - Written report submitted. Councilor Cable read over it.

Report of Council President – John Geiger – Five emergency ordinances this evening.

<u>Report of Mayor</u> — Mayor Peggy Wells read over her written submitted report. Mayor Wells suggested that Council identify more village-owned lots to put up for auction, as the village would save money in advertising that way. Councilor Goodman reminded Council that the revenue from the sale of village-owned lots will go back to the General fund to pay back the General fund for the cash purchase of the 118 Third Street Youth Association property.

Council President Geiger said yes, we would still want to see anticipated revenue stream. Councilor Goodman said there would be expense to the village regarding repairing the roof. Councilor Zwissler said there is liability during the process, as well as no available parking. Councilor Lemmon said before making Sylvana jump through hoops, council needs to decide if they even want to rent out the space. He does not think it is a good move for the village right now. Will be moved to the next meeting.
