The certification from the county states that this renewal levy will generate \$110,673 which is consistent with past years. Councilor Zwissler expressed the need for the police department if future development of the village is desired. The department helps raise the quality of life for the community. Councilor Geiger highlighted that this is not only important to existing residents but also new that are moving in.
