<u>Approval of Clerk Treasurer's Report:</u> Motion by Councilor Goodman, seconded by Councilor Lemmon, to approve the reconciliations for September and the Treasurer's report dated October 7, 2021.

Discussion: Treasurer Jennifer Dennis told council that reports for October have been completed and that the Recovery Act report that was to be due this month is now pushed back to April 2022.

APPOINTMENTS AND PRESENTATIONS: Broadband for the village – presenters Matt Armstead and Kyle Yoder from Ohio Transparent Telecom (OhioTT.com) spoke to council about a more affordable, high-quality broadband internet service option for the village. OhioTT started in May 2021, installed equipment in Somerset and are in talks with other communities throughout Ohio, primarily focused on public-private partnerships. Looking to obtain funds from grants from the Federal or State level to support new equipment for more affordable internet in the village and surrounding areas. Councilor Goodman asked what about a senior citizen who is not tech savvy? Which program would be the best / what is the average senior rate? Kyle suggested starting with the lower package at \$29.99 for 25 Mbps internet speed. If that is not enough, it can be bumped up. Most people are going with the middle package at \$49. An internet tower would need to be put up but does not have to be on village-owned property. Only a 50x50 square would be needed with electricity, and that could be privately owned. Other municipalities have their tower on their water tower, as the higher the tower, the better the service and coverage. A 300ft tower gave a 4-mile circle range. No contracts, it is month-to-month service with a \$99 install fee. Their goal is to provide 70% of their profits back. Possibility of using ARPA funds to help residents with the \$99 install fee. They have worked with Peter Voderberrg of BroadbandOhio on applying for a grant from NTIA to find every available source of funding. They are looking to deliver service for the unserved and underserved. Most places have kids who would be able to do schooling from home, working from home, helping seniors who are isolated

from family, telehealth from home. Also able to provide 5G cellular to add hotspots to the fire trucks.

COUNCIL STANDING COMMITTEE REPORTS:

<u>Finance Committee:</u> Budget coming up quickly. Hope to have something for the next meeting for it. Next Finance Committee meeting will be October 25th at 6:30pm. Finance Committee recommends to go ahead with the appropriation that is on the agenda tonight.

Public Safety Committee: Absent, no report.

Public Service Committee: Last meeting held on October 4th at 6:30pm. Ron Bennett, an engineer from ADR, came to the meeting to answer any questions and there was good discussion. Some individuals wanted to have the engineers to expand the Cranberry storm water study. Trash contract for the village is out for bid. Bids are due October 15th. Waiting on permits for the Taco Bell bridge project. Status of Neel Avenue storm water issue. Project is out for bid but there was a significant increase in cost to about \$110,000 due to economic conditions. Should be hearing about North Bank storm water soon. There was a quick review of Park Street project. ADR sent a package out for the Cranberry storm water feasibility study where they expanded the feasibility alternatives with a new price of \$47,500, which is a significant increase from the initial \$6,200 for task one. Next Public Service Committee meeting will be November 1st at 6:30pm where they will talk again about the Cranberry storm water feasibility study. Even if the engineers say that nothing can be done for the storm water, the village still needs to pay to figure that out.

<u>Rules Committee:</u> Meeting held on October 4th with general discussion of public hearings process and council rules relating to ORC 713.11 and 713.12. Talked about, if needed, getting back to committees meeting on off-Monday days that are not council nights. Next Rules Committee meeting to be held on November 1st at 6:00pm with more discussion about the public hearing process, verbiage for meeting on off-Mondays, and process of approval voting process of president and other appointments.

<u>Community Development Committee</u>: Community Development meeting held this evening before the council meeting where presenters from Ohio Transparent Telecom spoke to council about the options they have for getting affordable broadband internet in the village and the possibility of grant funding for it. Next Community Development meeting will be October 25th at 6:00pm with broadband follow-up.

<u>Personnel Committee:</u> Meeting held tonight before council meeting to discuss bonuses related to ARPA funds for staff. Appropriation for bonuses for fire and police department is on the agenda tonight. Will be able to give volunteers of the fire department bonuses as well but need to figure out the process for them to receive it, as it will be a sub-grant. Personnel Committee recommends the bonuses for village office workers to full council. Began discussion for 2022 budget on increasing stipends.

<u>Report of Council President – John Geiger</u> – Special council meeting and public hearing to be held on October 18th at 7pm for the short-term rental draft document about zoning code changes and the application process that was sent to council from the Planning and Zoning Commission (first draft document dated October 7, 2021).

Report of Mayor — There will be a Meet the Candidates night for the mayoral and council candidates at the Fire Department on October 14th from 6:30-8:30pm, with Mayor Layton of Hebron as the moderator. Candidates will be introduced and will have a chance to speak and Mayor Wells welcomes residents to come. Mayor Wells read compliments of the police department on Facebook. Fire Chief Ryan Wyse gave her a list of equipment the fire department really needs. Seven items listed that need to be replaced or purchased for the first time totaling \$14,362.28. There is a staffing shortage at the fire department and they are not always able to have a paramedic go on emergency runs. She said the village needs to get a Fire levy on the ballot in May and find the money to give them raises. Councilor Cable asked if reporting of issues around North Bank to the police has gotten better or worse. Police Chief Jason Harget came to the microphone to say it has stayed the same and to tell residents to please report even small thefts from their porches because it could lead to larger thefts. Police Chief said he is patrolling websites, is out on bike, and walking North Bank area. Councilor Lemmon asked if a golf cart or side-by-side would help him, and Chief said yes.

Any contract or money spent will still need to go to the mayor and council. Mayor Wells suggested the need for a seasonal worker to maintain the property (land) that came with the purchase of 118 Third Street by the village. Councilor Lemmon said he has seen other municipalities who have a part time worker under the street department. Councilor Zwissler wondered about the roof and electrical of the 118 Third Street building. Mayor Wells has not received any calls back about those things and the Parks and Recreation Commission can work on that.

<u>Councilor Cable:</u> Discussions have been direct and heated, and these are tough decisions that will impact people for a long time, including some of their livelihoods. Thanked members of council.

Councilor French: Thanked Councilor Zwissler for bringing up the broadband discussion.
