AN ORDINANCE AMENDING ORDINANCE NUMBER 81-4 BY CHANGING THE LOCATION OF PUBLIC POSTING PLACES WITHIN THE VILLAGE OF BUCKEYE LAKE, OHIO.

Section 1: Section 1 of Ordinance 81-4 currently reads as follows:

The Clerk is hereby directed to post all Resolutions, Statements, Orders, Proclamations, Notices, and Reports required by law to be published in the following locations which Council determines to be the most public places in the Village:

- 1. BancOhio Office
- 2. Post Office
- 3. Mt. Carmel Fellowship Hall
- 4. Gardner's Grocery Store
- 5. Lakewood Market
- 6. Betty's Corners

Section 2: The above Section is hereby amended to read as follows:

The Clerk is hereby directed to post all Resolutions, Statements, Orders, Proclamations, Notices, and Reports required by law to be published in the following locations which Council determines to be the most public places in the Village:

- 1. Post Office - cliff board on left wall
- 2. Mt. Carmel Fellowship Hall
- 3. Cardinal Food Gallery - outside showcase by exit
- 4. ~~Betty's Corners~~ ^{BANK MART} - cliff board near entrance door
- 5. Buckeye Lake Village Hall - window and bulletin board
- 6. Binky's Party House - bulletin board
- 7. BancOhio - south entrance bulletin board
- 8. Charley Ramsey's Barber Shop - Walnut Road

Section 3: This Ordinance shall go into full force and effect from and after the earliest period allowed by law.
