ORDINANCE NUMBER ashwald BY AN ORDINANCE ESTABLISHING HOURS OF OPERATION FOR RYAN PARK AND ESTABLISHING CRIMINAL PENALTIES FOR VIOLATION THEREOF. WHEREAS, Council has received numerous complaints from citizens concerning activities going on in Ryan Park after dark. AND, WHEREAS, Council is desirous of eliminating the problems associated with the use of Ryan Park in the evening hours. NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, That: Section 1: Ryan Park, a village-owned park, is hereby closed to the public from one-half hour after sunset until sunrise, each and every day of the week. Section 2: Individuals who violate these hours and are upon the Ryan Park grounds following one-half hour after sunset and before sunrise shall be prosecuted for criminally trespassing upon village property. Penalties for violation shall be the same as are established for the offense of criminal trespassing in the Codified Ordinances of the Village of Buckeye Lake, Ohio. Section 3: The Mayor is hereby authorized to place signs in the area of Ryan Park informing the public of the hours of operation of the Park. Section 4: This Ordinance shall go into full force and effect from and after the earliest period allowed by law. Adopted this both day of luquest, 1984.
