AN ORDINANCE PERMITTING THE MAYOR OF THE VILLAGE OF BUCKEYE LAKE, OHIO, TO RETAIN AS HIS PERSONAL PROPERTY, ALL FUNDS RECEIVED BY THE MAYOR FOR PERFORMING MARRIAGES IN HIS CAPACITY AS MAYOR OF THE VILLAGE.

WHEREAS, from time to time the mayor is called upon to perform civil marriage ceremonies, and

WHEREAS, performing said ceremonies consumes the mayor's time, and

WHEREAS, council desires that the fees the mayor charges for performing such wedding ceremonies go directly to him and not be considered village assets.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

Section 1: Henceforth, the Mayor of the Village of Buckeye Lake is hereby authorized to retain as his own personal property any funds paid to him in his capacity as mayor, for performing civil wedding ceremonies.

Section 2: It is the intent of council to specifically waive any right the village may have to these funds by virtue of the fact that they are received by the mayor.

Section 3: This Ordinance shall go into full force and effect from and after the earliest period allowed by law.
