PREAMBLE

An ordinance of the Village of Buckeye Lake, Licking County, Ohio, enacted in accordance with a comprehensive plan and the provisions of Chapter 713, Ohio Revised Code, dividing the village into zones and districts, encouraging, regulating, and restricting therein the location, construction, reconstruction, alteration and use of structures and land; promoting the orderly development of residential, business, industrial, recreational, and public areas; providing for adequate light, air, and convenience of access to property by regulating the use of land and buildings and the bulk of structures in relationship to surrounding properties; limiting congestion in the public right-of-way; providing for the compatibility of different land uses and the most appropriate use of land; and powers and duties of the administrative officers as provided hereafter, the prescribing of penalties for the violation of the provisions in this ordinance of any amendment thereto, all for the purpose of protecting the public health, safety, comfort, and general welfare:

ARTICLE 1

Section 100 Title

This ordinance shall be known and may be cited to as the "Village of Buckeye Lake, Ohio Zoning Ordinance."

Section 101 Provisions Declared Minimum Requirements

In their interpretation and application, the provisions of this ordinance shall be held to be minimum requirements, adopted for the promotion of the public health, safety, and the general welfare. Wherever the requirements of this ordinance conflict with the requirements of any other lawfully adopted rules, regulations, ordinances, or resolutions, the most restrictive, or that imposing the higher standards shall govern.

Section 102 Separability Clause

Should any section or provisions of this ordinance be declared by the courts to be unconstitutional or invalid, such decision shall not affect the validity of the ordinance as a whole, or any part thereof other than the part so declared to be unconstitutional or invalid.

Section 103 Repeal of Conflicting Ordinance, Effective Date

All ordinances or parts of ordinances in conflict with this zoning ordinance or inconsistent with the provisions of this ordinance are hereby repealed to the extent necessary to give this ordinance full force and affect. This ordinance shall become effective from and after the date of its approval and adoption, as provided by law.


