AN ORDINANCE AUTHORIZING AND DIRECTING THE LITTER GRANT SUPERVISOR TO ACT AS ENFORCEMENT OFFICER CONCERNING THE PROPERTY MAINTENANCE CODE OF THE VILLAGE OF BUCKEYE LAKE, OHIO. *and declaring an emergency*

WHEREAS, the responsibilities of the Litter Grant Supervisor and the position of Code Official under the Property Maintenance Code have many similarities; and -

WHEREAS, the Village is currently without a Code Official and still desires to see the Property Maintenance Code enforced; *and concerning articles 1, 2, 3 & 8 be*

WHEREAS, because of the similarities of responsibilities, the Council wishes to temporarily combine these positions.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING, AND STATE OF OHIO, that:

Section 1: The Buckeye Lake Village Litter Grant Supervisor is hereby authorized to act as Code Official for the Village of Buckeye Lake, Ohio.

Section 2: The Code Official/Litter Grant Supervisor shall receive no greater compensation than he is currently authorized to receive by virtue of said individual's contract with the Village.

Section 3: This Ordinance shall go into full force and effect from and after the earliest period allowed by law.
