ORDINANCE NO. 85-09

AN ORDINANCE CHANGING THE PROCEDURE FOR PAYMENT OF VILLAGE COUNCIL MEMBERS.

WHEREAS, Council is desirous of establishing a different system for payment of Council members; and,

WHEREAS, the change will not effect the amounts paid to Council members each year for their service to the Village,

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

Section 1: From and after January 1, 1986, Village Council members shall be paid \$240.00 per annum.

Section 2: The above amount shall be payable in twelve equal installments and shall be disbursed by the Clerk at each of the second council meetings of each and every month.

Section 3: Council members shall be paid the above amount by virtue of their being Council members and not according to how many or few meetings are attended.

Section 4: This Ordinance shall go into full force and effect from and after the 1st day of January, 1986.
