

ORDINANCE NO. 86-07

AN ORDINANCE CHANGING THE NAME OF NORTH STREET IN THE ELLIOT ADDITION OF THE VILLAGE OF BUCKEYE LAKE, OHIO.

WHEREAS, a duplication of street names now exists in the Village of Buckeye Lake, Ohio, and

WHEREAS, in order to avoid confusion, it is desirable to not have duplication of street names.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, THAT:

Section 1: Section 723.05 of the Ohio Revised Code authorizes the village council, when there are two or more streets of the same name in a village to, by ordinance, change the name of any such street so as to leave only one to be designated by the original name.

Section 2: North Street in the Elliot Addition of the Village of Buckeye Lake, Ohio, is hereby changed to and shall be hereafter referred to as Northmore.

Section 3: This Ordinance shall go into full force and effect from and after the earliest period allowed by law.
