

ORDINANCE NUMBER 86-10

AN ORDINANCE CHANGING THE NAME OF STATE ROUTE #79 INSIDE THE VILLAGE OF BUCKEYE LAKE, OHIO, WHICH IS NOW KNOWN AS HEBRON ROAD (FOUR LANE AREA) AND WALNUT ROAD.

WHEREAS, the Public Service Committee of the Village of Buckeye Lake, Ohio, is desirous of changing the name of State Route #79 inside the Village of Buckeye Lake, Ohio, which is now known as Hebron Road (four lane area) and Walnut Road to that of Blue Heron Drive.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, THAT:

Section 1: State Route #79 inside the Village of Buckeye Lake, Ohio, now known as Hebron Road (four lane area) and Walnut Road is hereby changed to Blue Heron Drive.

Section 2: This Ordinance shall go into full force and effect from and after the earliest period allowed by law.
