A ORDINANCE TO LIMIT PARKING ON WALNUT ROAD S.E. IN THE VILLAGE OF BUCKEYE LAKE OHIO.

WHEREAS, IN ORDER TO PROTECT THE HEALTH, SAFETY AND WELFARE OF ITS CITIZENS, COUNCIL HAS RECOGNIZED THE NEED TO LIMIT PARKING ALONG THE ROADWAY AND BERM OF WALNUT ROAD S.E., WITHIN THE VILLAGE OF BUCKEYE LAKE, AND

WHEREAS, OHIO LAW PROVIDES THAT SUCH LIMITATION MAY BE ESTABLISHED BY THE LEGISLATIVE AUTHORITY IN WHICH A STATE ROADWAY IS LOCATED.,


NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, A MAJORITY OF THE MEMBERS ELECTED THERETO CONCURRING, THAT;

SECTION ONE: THERE SHALL BE NO PARKING UPON ANY PORTION OF THE ROADWAY OR BERM OF WALNUT ROAD S.E., ALSO KNOWN AS STATE ROUTE 79 FROM THE INTERSECTION OF HEBRON ROAD (RUNNING SOUTH) AND WALNUT ROAD (RUNNING WEST) AT THE ENTRANCE TO THE STATE PARK TO THE WESTERN CORPORATION LIMIT OF THE VILLAGE OF BUCKEYE LAKE.


SECTION TWO: THE IMPLEMENTATION OF THIS ORDINANCE SHALL BE SUBJECT TO ASSENT BY THE OHIO DEPARTMENT OF TRANSPARATION.

SECTION THREE: THIS ORDINANCE SHALL BE INCORPORATED BY REFERENCE AND BE A PART OF THE MODEL OFFENSE CODE OF THE VILLAGE OF BUCKEYE LAKE AND SHALL BE IDENTICAL IN PENALTY TO OTHER SUCH PARKING ORDINANCES CONTAINED THEREIN PROHIBITING ROADWAY AND/OR BERM PARKING.



AMENDED ORDINANCE 99-08

A ORDINANCE TO LIMIT PARKING ON WALNUT ROAD S.E. IN THE VILLAGE OF BUCKEYE LAKE OHIO.

WHEREAS, IN ORDER TO PROTECT THE HEALTH, SAFETY AND WELFARE OF ITS CITIZENS, COUNCIL HAS RECOGNIZED THE NEED TO LIMIT PARKING ALONG THE ROADWAY AND BERM OF WALNUT ROAD S.E., WITHIN THE VILLAGE OF BUCKEYE LAKE, AND

WHEREAS, OHIO LAW PROVIDES THAT SUCH LIMITATION MAY BE ESTABLISHED BY THE LEGISLATIVE AUTHORITY IN WHICH A STATE ROADWAY IS LOCATED.,

NOW THEREFORE BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, A MAJORITY OF THE MEMBERS ELECTED THERETO CONCURRING, THAT;

SECTION ONE: THERE SHALL BE NO PARALLEL PARKING WITHIN TEN (10) FEET ^{OF} THE ROADWAY PAVEMENT EDGE ON THE NORTH SIDE OF STATE RTE. 79, AKA WALNUT ROAD S.E., , FROM THE NORTH SHORE BOAT RAMP PARK TO THE WESTERN CORPORATION LIMITS OF THE VILLAGE OF BUCKEYE LAKE.

SECTION TWO: THE IMPLEMENTATION OF THIS ORDINANCE SHALL BE SUBJECT TO ASSENT BY THE OHIO DEPARTMENT OF TRANSPORTATION. TRANSPORTATION,


SECTION THREE: THIS ORDINANCE SHALL BE INCORPORATED BY REFERENCE AND BE A PART OF THE MODEL OFFENSE CODE OF THE VILLAGE OF BUCKEYE LAKE AND SHALL BE IDENTICAL IN PENALTY TO OTHER SUCH PARKING ORDINANCES CONTAINED THEREIN PROHIBITING ROADWAY AND/OR BERM PARKING.

SECTION FOUR: THIS ORDINANCE SHALL BECOME EFFECTIVE FROM AND AFTER THE EARLIEST PERIOD ALLOWED BY LAW.
