ORDINANCE AMENDING ORDINANCE 2002-01 A TEMPORARY APPROPRIATIONS ORDINANCE
TO APPROPRIATE AN ADDITIONAL \$730 FOR EDUCATION IN STREET DEPARTMENT BUDGET
AND DECLARING AN EMERGENCY

WHEREAS, the Council of the Village of Buckeye Lake, Ohio previously passed into law Ordinance 2002-01 for the purpose of providing temporary appropriations;

WHEREAS, it has become necessary to amend Ordinance 2002-01 to add an appropriation for \$730 for education in the street department appropriations; and

WHEREAS, Ohio Revised Code Section 731.17(A)(2) requires public reading of an ordinance to occur on three separate days, unless three-fourths of the members of the legislature affirmatively vote to dispense with such requirement.

THEREFORE,

FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST THREE-FOURTHS (3/4) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF 731.17(A)(2) TO READ AN ORDINANCE ON THREE SEPARATE DAYS,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, OHIO:

SECTION 1: That to provide for the current expenses during the interim period between January 1, 2002 and March 31, 2002, Ordinance 2002-01 is amended to read as follows and the following sums be and hereby are set aside and appropriated as follows:

SECTION 2: That the Village Clerk is authorized to draw her warrants on the Village Treasury for the payment of any of the foregoing appropriations upon receiving proper certificates and vouchers therefore approved by the same or an Ordinance or Resolution of Council to make expenditures, provided that no warrants shall be drawn or paid for salaries or wages except for persons employed by the authority of and in accordance with the laws and ordinances of the Village of Buckeye Lake and provided further that the appropriations can only be expended upon a two-thirds (2/3) vote of Council for items of expense constituting a legal obligation against the Village and for the purposes other than those covered by specific appropriations herein made.


SECTION 3: That in order to protect the health, safety and welfare of the citizens of the Village of Buckeye Lake in that monies are immediately needed to meet salaries and payroll so that the Village employees may continue to perform their duties this Ordinance is declared to be an emergency measure and it shall become effective on its passage and signature of the Mayor.
