ORDINANCE NUMBER 2002 – 08

**AN ORDINANCE TO AMEND THE FISCAL YEAR 2002 APPROPRIATIONS
ORDINANCE 2002 - 07, BY DECREASING CONTINGENCY FUND \$1,000 AND
INCREASING STREET DEPARTMENT 2011 EMPLOYMENT RELATED FUNDS
AND DECLARING AN EMERGENCY**

WHEREAS, Ohio Revised Code § 5705.38 empowers the municipal legislative authority to pass supplemental appropriations measures as it finds necessary;

WHEREAS, the current employment plans for the street department will require additional funds for payment of salaries and employment related expenses for the remainder of the current fiscal year, which funds are available from the contingency fund;

WHEREAS an emergency exists in that the employment plans for the street department will be disrupted unless this and related actions concerning payments to certain municipal employees are approved and payments made in a timely manner; and

WHEREAS, Ohio Revised Code Section 731.17(A)(2) requires public reading of a resolution to occur on three separate days, unless three-fourths (3/4) of the members of the legislature affirmatively vote to dispense with such requirement.

THEREFORE.

**FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST THREE-FOURTHS (3/4)
OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF 731.17(A)(2)
TO READ AN ORDINANCE ON THREE SEPARATE DAYS,**

**BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE,
OHIO:**

Section 1. That the 2002 Appropriations Ordinance 2002 - 07, is hereby amended by decreasing the Contingency Fund 930-930 by one thousand dollars (\$1,000.00) and increasing the Street Department 2011-620-190-Salaries; 2011-620-211 PERS. and 2011-620-213 Medicare employment related funds an aggregate amount of one thousand dollars (\$1,000.00).

Section 2.

That in order to protect the health, safety and welfare of the citizens of the Village of Buckeye Lake, this Resolution is declared to be an emergency measure and it shall become effective on its passage and signature of the Mayor. This ordinance shall go into full force and effect immediately in accordance with Ohio Revised Code § 731.30, inasmuch as it provides for an appropriation of current operating expenses of the Village and it has received the affirmative votes of at least two-thirds of the members of the Village Council.
