

ORDINANCE NO. 2004 - 06
VILLAGE OF BUCKEYE LAKE, OHIO

A ORDINANCE TO CREATE THE POSITION OF CLERK OF COUNCIL, HIRE A CLERK OF COUNCIL, FIX THE HOURS AND COMPENSATION THEREFOR AND DECLARE AN EMERGENCY

WHEREAS, the Village of Buckeye Lake, Licking County, Ohio, is currently in need of a permanently filling the Clerk of Council position created by the Charter to conduct the business of the Village; and

WHEREAS, the members of Council of the Village of Buckeye Lake deem it necessary and advisable to hire and employ a part time Clerk of Council in order to provide the Village Council with the necessary support staff; and

WHEREAS compensation for said Clerk of Council has been appropriated from the general fund of the Village and there are sufficient funds available for such purpose; and

WHEREAS Keith McQuillen has been the acting Clerk of Council since February of 2004; and

WHEREAS, The Buckeye Lake Village Charter requires public reading of an ordinance to occur on three separate days, unless three-fourths of the members of the legislature affirmatively vote to dispense with such requirement.

NOW THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE VILLAGE OF BUCKEYE LAKE THAT FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST THREE-FOURTHS (3/4) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER TO READ AN ORDINANCE ON THREE SEPARATE DAYS,

Section 1. That Keith McQuillen hereby is hired as a part time at will employee of the Village of Buckeye Lake in the position of Clerk of Council at a rate of \$9.50 per hour.

Section 2. That the times and number of hours Mr. McQuillen shall work will be fixed by the Council, but he shall work less than five (5) hours per week.

Section 3. Council declares this to be an emergency measure immediately necessary for the preservation of the public health, safety, welfare, and morals, such emergency arising out of the necessity to provide for the continued and effective operation of the Village government without the due delay and in order to correct a situation now deemed undesirable; wherefore this ordinance shall take effect and be in force from and after its passage.

Section 4. Each section and each part of each section of this Resolution is hereby declared to be an independent section or part of a section and, notwithstanding any other evidence of legislative intent, it is hereby declared to be the controlling legislative intent that if any such section or part of a section, or any provision thereof, or the application thereof to any person or circumstances, is held to be invalid, the remaining sections or parts of sections and the application of such provision to any other person or circumstances, other than those to which it is held invalid, shall not be affected thereby, and it is further

declared to be the legislative intent that the other provisions of this Resolution would have been adopted independently of such section, sections or parts of a section so held to be invalid.


