

## ORDINANCE 2004-11

AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH LEADS FOR LICENSING USE OF THE PLAYGROUND LOCATED AT 41 1<sup>ST</sup> STREET, BUCKEYE LAKE, OHIO 43008 AND DECLARING AN EMERGENCY

WHEREAS, the Buckeye Lake Council currently owns a piece of property previously leased by LEADS; and

WHEREAS, at the request of the LEADS the Village desires enter into a license agreement with LEADS for the continued use of the playground equipment located at 41 1<sup>st</sup> Street, Buckeye Lake, Ohio 43008 and associated uses normally incidental thereto and for no other person, or purpose;

WHEREAS, Council finds it is in the best interest of the Village to enter into this agreement with LEADS for the continued services LEADS provides within Buckeye Lake.

WHEREAS, The Buckeye Lake Village Charter requires public reading of an ordinance to occur on three separate days with at least one week between readings, unless three-fourths of the members of the legislature affirmatively vote to dispense with such requirement.

THEREFORE,

FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST THREE-FOURTHS (3/4) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER SECTION 4.04 TO READ AN ORDINANCE ON THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN READINGS,

BE IT ORDAINED by the Council, of the Village of Buckeye Lake, State of Ohio, \_\_\_\_\_ of the elected members concurring that:

Section 1. Buckeye Lake Village Council authorizes the Mayor to enter into a license agreement with LEADS for the use of playground equipment at 41 1<sup>st</sup> Street, Buckeye Lake, Ohio 43008 which shall be utilized as a playground and associated uses normally incidental thereto and for no other person, or purpose;

Section 2. This ordinance is hereby declared to be an emergency necessary to assist LEADS in providing their services in the Village of Buckeye Lake. Therefore, this ordinance shall go into immediate effect.


