

**VILLAGE OF BUCKEYE LAKE, OHIO**  
**ORDINANCE NUMBER 2004 - 13**

**AN ORDINANCE AUTHORIZING THE MAYOR TO NEGOTIATE AND ENTER INTO A STREET  
PAVING CONTRACT WITH THE SHELLY COMPANY, APPROPRIATE FUNDS TO DO SO AND  
DECLARE AN EMERGENCY**

**WHEREAS**, the Village of Buckeye Lake intends to pave certain streets within the Village; and

**WHEREAS**, the Village Council previously advertised for bids to pave said streets within the Village and received only one bid; and

**WHEREAS**, the Village Council wishes to reduce the extent of the paving and negotiate a new price which will be less than \$20,000.00; and

**WHEREAS**, the Village desires to execute an agreement with The Shelly Company in a substantially similar form as attached Exhibit "A".

**NOW, THEREFORE,**

FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST THREE-FOURTHS (3/4) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER SECTION 4.04 TO READ AN ORDINANCE ON THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN READINGS, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, OHIO:

**Section 1:** Village of Buckeye Lake Council authorizes the Mayor to negotiate and enter into a street paving agreement with The Shelly Company in a substantially similar form to the attached Exhibit "A".

**Section 2:** The Village of Buckeye Lake Council hereby amends Ordinance 2004-01 Permanent Appropriations Ordinance by increasing account 2101-610-396 Streets, Highways, Curbs and Sidewalks by \$10,000.00 to a total appropriation in that fund of \$20,000.00 for fiscal 2004.


**Section 3:** That in order to protect the health, safety and welfare of the citizens of the Village of Buckeye Lake in that in paving the identified streets this calendar year is in the best interest of the residents of the Village of Buckeye Lake this Ordinance is declared to be an emergency measure and it shall become effective on its passage and signature of the Mayor.
