

ORDINANCE 2008-02

AN ORDINANCE APPROVING, ADOPTING AND ENACTING A VILLAGE-WIDE COMPREHENSIVE PLAN FOR THE VILLAGE OF BUCKEYE LAKE, OHIO.

WHEREAS, the Village of Buckeye Lake wishes to express their appreciation to Licking County Planning Commission and the members of the Buckeye Lake Comprehensive Plan Committee for their assistance in the creation of a Village-wide Comprehensive Plan; and

WHEREAS, the volunteer committee members, Licking County Planning Commission staff, Village employees and Village elected officials have spent countless hours gathering public input, drafting recommendations, meeting to gain consensus and publicizing this project to the community; and

WHEREAS, the Village administration and Village Council see the importance of adopting this plan as an official Planning Document of the Village of Buckeye Lake; and

WHEREAS, the Village-wide Comprehensive Plan has been reviewed and recommended for adoption by the Village of Buckeye Lake Planning Commission as well as the Licking County Planning Commission; and

WHEREAS, the Buckeye Lake Village Council members have received and reviewed a copy of the aforesaid plan,

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Buckeye Lake, County of Licking, State of Ohio, a majority of the members concurring:

Section 1: Council has determined that adoption of a comprehensive plan for the Village of Buckeye Lake is in the best interest of the Village.


Section 2: Council has determined that the Village of Buckeye Lake Comprehensive Plan will be an excellent tool to guide development during the next twenty years.

Section 3: Council hereby adopts and enacts the Village of Buckeye Lake Comprehensive Plan in its entirety until a time at which Council adopts a suitable update to the plan.

Section 4: It is hereby found and determined that all formal actions of this Village Council and any of its committees concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council or committees, and that all deliberations of this Council and of any of its committees that resulted in those formal actions were in meetings open to the public, all in compliance with the law.

Section 5: This Ordinance shall be in full force and effect from the earliest date provided by law.


