AN ORDINANCE AMENDING ORDINANCE 2010-36 AND ESTABLISHING NEW WATER RATES AND COLLECTION GUIDELINES FOR THE VILLAGE OF BUCKEYE LAKE WATER DISTRIBUTION SYSTEM, AND DECLARING AN EMERGENCY.

NOW THEREFORE BE IT ORDAINED by the Council of the Village of Buckeye Lake, Ohio as follows:

Section 5: The Village reserves the right to review and revise their rate structure as needed.

Section 6: That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.

<u>Section 3</u>: That this Ordinance is hereby declared to be an emergency measure necessary for the public health, safety and welfare, such emergency being the need to have all the fees and charges in effect for the billing cycle, and therefore, shall take effect immediately upon its passage by Council and approval by the Mayor.
