AN ORDINANCE AMENDING ORDINANCE 2010-45, 2011-14 AND 2012-07 AND CREATING PAY LEVELS AND SALARY SCHEDULES FOR EMPLOYEES OF THE VILLAGE OF BUCKEYE LAKE, OHIO

Be It Ordained by the Village of Buckeye Lake, State of Ohio:
