

ORDINANCE NO. 2013-01

AN ORDINANCE AMENDING ORDINANCE 2010-45, 2011-14, 2012-07, 2012-13 AND 2012-15 CREATING NOT TO EXCEED (NTE) PAY LEVELS AND SALARY SCHEDULES FOR EMPLOYEES OF THE VILLAGE OF BUCKEYE LAKE, OHIO

Be It Ordained by the Village of Buckeye Lake, State of Ohio:

SECTION 1: Ordinance 2010-45, 2011-14, 2012-07, 2012-13 and 2012-15 are amended and the following pay levels and schedules are hereby adopted:
