# AMENDING ORDINANCE 2018-16 PERMANENT APPROPRIATIONS ORDINANCE AND DECLARATION OF EMERGENCY

An ORDINANCE to amend appropriations for Current Expenses and Other Expenditures of the Village of Buckeye Lake, State of Ohio, during the year ending December 31, 2018.

WHEREAS, The Buckeye Lake Village Council adopted Ordinance 2018-16; and

WHEREAS, it is necessary to revise appropriations set forth in Ordinance 2018-16 in accordance with the provisions of Section 5705.38 through 5705.40 of the Ohio Revised Code (ORC).

THEREFORE, FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST TWO THIRDS (2/3) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER SECTION 4.04 TO READ AN ORDINANCE ON THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN READINGS,

<u>Section 6:</u> That in order to protect the health, safety and welfare of the citizens of the Village of Buckeye Lake in that monies are immediately needed to meet salaries, payroll and other expenses so that the Village may continue to pay authorized expenditures this Ordinance is declared to be an emergency measure and it shall become effective on its passage and signature of the Mayor.
