

VILLAGE OF BUCKEYE LAKE

ORDINANCE NO. 2020-15

AN ORDINANCE APPROVING AND AUTHORIZING THE MAYOR TO EXECUTE A CONTRACT BETWEEN ADR & ASSOCIATES, LTD. AND THE VILLAGE OF BUCKEYE LAKE FOR LAND SURVEYING, CIVIL ENGINEERING AND CONSTRUCTION ADMINISTRATION SERVICES FOR THE OPWC NORTH BANK EAST STORMWATER IMPROVEMENTS PROJECT, AND DECLARING AN EMRGENCY

WHEREAS, the Village of Buckeye Lake Stormwater Utility Capital Improvement Plan recommends improving the drainage on North Bank east of ODNR Spill way; and,

WHEREAS, Council has determined it to be in the best interest of the Village of Buckeye Lake, and its residents, to approve a Contract between ADR & ASSOCIATES, LTD. and the Village of Buckeye Lake for the OPWC North Bank East Stormwater Improvements Project,

THEREFORE, FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST TWO THIRDS (2/3) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER SECTION 4.04 TO READ AN ORDINANCE ON THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN READINGS,

BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, OHIO:

SECTION I: That the Contract is hereby approved, and the Mayor be, and she hereby is, authorized and directed to execute a Contract between ADR & ASSOCIATES, LTD. and the Village of Buckeye Lake. For land surveying, civil engineering and construction administration, as it pertains to OPWC North Bank East Stormwater Improvements Project.

SECTION III: That in order to protect the health, safety and welfare of the citizens of the Village of Buckeye Lake in that to provide for the expedition of construction at time funds are released, and the ability for engineering service to be completed with potential low staff levels due to ongoing pandemic in an timely manner, this Ordinance is declared to be an emergency measure and it shall become effective on its passage and signature of the Mayor.
