WHEREAS, the Change Order herein modifies the terms and conditions of the aforementioned contract to complete additional site work, at an increase in the contract price from \$27,398.00 to \$32,198.00; and

WHEREAS, the need for an access road to the pavilion was included in the design, but was not part of the bid. Moneys are left to complete this work with-in the funding amount.
