

**ORDINANCE NO. 2026-03**  
**VILLAGE OF BUCKEYE LAKE**  
**FIRST READING**

**AN ORDINANCE CREATING THE HOLTSBERRY CABIN FUND.**

---

**WHEREAS**, the Village of Buckeye Lake, Ohio, is organized under the laws of the State of Ohio and Home Rule of the Ohio Constitution, pursuant to the Village Charter; and

**WHEREAS**, the Village recently received the historic Holtsberry Cabin on permanent loan from the Greater Buckeye Lake Historical Society; and

**WHEREAS**, to account for income and expenses, the Village needs to create a permanent fund;

**NOW, THEREFORE, FOLLOWING AN AFFIRMATIVE VOTE OF AT LEAST TWO THIRDS (2/3) OF THE COUNCIL TO DISPENSE WITH THE REQUIREMENT OF THE BUCKEYE LAKE VILLAGE CHARTER SECTION 4.04 TO READ AN ORDINANCE ON THREE SEPARATE DAYS WITH AT LEAST ONE WEEK BETWEEN READINGS, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, STATE OF OHIO:**

**SECTION 1:** That the Holtsberry Cabin Fund is hereby established for use only with Holtsberry Cabin. All donations to the Village for Holtsberry Cabin shall be placed in such Fund. All fees, charges, and other sources of revenue generated by programs and activities at Holtsberry Cabin shall be deposited in such Fund. All moneys deposited in such Fund shall be expended for Holtsberry Cabin;

**SECTION 2:** That it is found and determined that all formal actions of this Council concerning and relating to the adoption of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council, and any of its committees that resulted in such formal action, were in meetings open to the public in compliance with all legal requirements of R.C. §121.22;

**SECTION 3:** That in order to protect the health, safety, and welfare of the citizens of the Village of Buckeye Lake in that monies are immediately needed to meet salaries, payroll, and other expenses so that the Village may continue to pay authorized expenditures, this Ordinance is declared to be an emergency measure and it shall become effective on its passage and signature of the Mayor.
