

RESOLUTION

IN THE MATTER OF ESTABLISHING A RESOLUTION OF COOPERATION  
BETWEEN THE VILLAGE OF BUCKEYE LAKE AND LICKING COUNTY *and Declaring*  
*an Emergency*

Whereas, the Board of County Commissioners has adopted a Fair Housing Plan for Licking County as a means of promoting and enforcing the letter and spirit of Federal and State Fair Housing laws for the residents of the County; and

Whereas, Licking County is participating in the Community Development Block Grant (CDBG) Program under the provisions of the Housing and Community Development Act of 1974; and

Whereas, this Board and the Village of Buckeye Lake are desirous of promoting Fair Housing Opportunities in accordance with the provisions of said act and program; and

Whereas, it is the intent of the Board and the Village of Buckeye Lake to work together in implementing the Licking County fair housing plan; and

Whereas, the Village of Buckeye Lake agrees to provide as much as 1% to 2% of any CDBG funds received in support of the fair housing program.

Therefore, BE IT RESOLVED by the Board of County Commissioners of Licking, State of Ohio and the Village of Buckeye Lake, Licking County, State of Ohio:

That this Board and the Village hereby adopt a resolution of cooperation between Licking County and the Village of Buckeye Lake on matters concerning assuring fair housing opportunities for all residents of Licking County. This resolution will be in force and effective thirty (30) days from and after its passage.

BE IT FURTHER RESOLVED:

THAT THE VILLAGE OF BUCKEYE LAKE APPOINTS AND THE COUNTY COMMISSIONERS ACCEPT THE APPOINTMENT OF THE FOLLOWING PERSON TO REPRESENT BUCKEYE LAKE ON THE LICKING COUNTY FAIR HOUSING COMMISSION:
