

RESOLUTION NUMBER 84-17

A RESOLUTION DECLARING THE BID SUBMITTED BY THE NEWARK ASPHALT PAVING COMPANY TO BE THE LOWEST AND BEST BID PURSUANT TO 731.14 OF THE OHIO REVISED CODE AND AUTHORIZING THE MAYOR AND CLERK TO ENTER INTO CONTRACT IN AN AMOUNT NOT TO EXCEED FOURTEEN THOUSAND DOLLARS (\$14,000.00) FOR THE PAVING OF CERTAIN STREETS WITHIN THE VILLAGE.

WHEREAS, it is Council's desire to upgrade the streets within the Village of Buckeye Lake, and,

WHEREAS, Council desires to proceed with the street paving project at the earliest possible time,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING, AND STATE OF OHIO, That:

Section 1: The bid submitted by Newark Asphalt Paving Company is hereby declared to be the lowest and best bid pursuant to Section 731.14 of the Ohio Revised Code.

Section 2: The Mayor and Clerk are hereby authorized to enter into contract with Newark Asphalt Paving Company in an amount not to exceed Fourteen Thousand Dollars (\$14,000.00) for the paving of certain streets to be designated by Council under a separate piece of legislation.

Section 3: An emergency is hereby declared to exist in that the current conditions of some streets within the Village necessitates their immediate repair to protect life and property.

Section 4: This Resolution shall go into effect immediately.
