This Agreemnt, is made and entered into by and between the Board of County Commissioners of Licking County, Ohio hereinafter "County" and the Village of Buckeye Lake, Ohio, hereinafter "Village," this <u>30</u>th day of <u>August</u>, 1984.

WHEREAS, the County has received grant funds from the State of Ohio, Department of Development under grant number BH-83-041; and

WHEREAS, the County through the Licking County Community Development Office is working with the Village on its revitalization project involving demolition of vacant, abandoned residences; and

WHEREAS, the Village is able to provide assistance in cleaning-up sites that have been demolished through actions of the fire department,

NOW THEREFORE, the County and the Village agree as follows:

That Village personnel under the direction of Ed Neff, Street Department, will be reimbursed for the clean-up of demolished houses. 2. Clean up will include: removal of burned material, rubbish, etc; supply of clean fill to restore site; grass seed, and other verifiable costs. 3. The County will reimburse the Village for dumping fees, mileage costs to an approved landfill site (at \$.30/mile for the dump truck and at \$.21/mile for regular vehicles), and mileage to the demolition site. 4. The County will reimburse the Village for direct personnel costs associated with the demolition on a per hour basis upon approved invoices from the Village.

The total amount of this contract shall not exceed \$6,000 and is effective as of the date of the County signatures.
