A RESOLUTION ESTABLISHING THE ANNUAL SALARY OF THE BUCKEYE LAKE VILLAGE MARSHALL, DESIGNATED CHIEF OF POLICE.

WHEREAS, Council desires to establish a new salary schedule for the Buckeye Lake Village Marshall and,

WHEREAS, Council desires this new salary schedule to be in effect with the hiring of the new Chief of Police,

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING, AND STATE OF OHIO, that:

Section 1: The salary schedule on a per annum basis for the Buckeye Lake Village Marshall, designated Chief of Police, is as follows:

- (a) From the date of appointment through a period six months from said date, the per annum salary of \$14,000.00.
- (b) From the completion of the Village Marshall's probationary period for a period of six months, the per annum salary of \$14,500.00.
- (c) Following the completion of the Village Marshall's first year in that position, the salary of \$15,000.00 per annum thereafter.

Section 2: This Resolution shall go into full force and effect from and after the earliest period allowed by law.
