A RESOLUTION ESTABLISHING THE RATE OF COMPENSATION TO BE PAID TO THE DEPUTY VILLAGE MARSHALL.

WHEREAS, the Mayor has recently appointed and Council has confirmed the appointment of a Deputy Village Marshall and,

WHEREAS, Council desires to establish a salary schedule for said individual.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, that:

Section 1: The Clerk is authorized to compensate the Deputy Village Marshall at a rate of \$11,500.00 per annum from and after his date of employment through a period of six months.

Section 2: Upon the satisfactory completion of said employee's probationary period, and upon Council confirming said employee's permanent status, the per annum salary for said position shall be increased to \$12,000.00.

Section 3: Said employee shall be entitled to, and the Clerk is directed to pay for, all fringe benefits to which other individuals in the Police Department receive.

Section 4: This Resolution shall take effect from and after the earliest period allowed by law.
