A RESOLUTION MADE PURSUANT TO SECTION 1717.07 OF THE OHIO REVISED CODE PERTAINING TO THE SALARY OF THE COUNTY HUMANE AGENT.

WHEREAS, a request has been received from the Humane Society of Licking County requesting that the Village fulfill the obligations imposed upon it by Section 1717.07 of the Ohio Revised Code, and

WHEREAS, it is Council's desire to meet the obligation imposed for calendar year 1984 and thereafter.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING AND STATE OF OHIO, THAT:

Section 1: The Clerk is hereby authorized to pay to the Licking County Humane Agent the sum of \$60.00 representing the Village of Buckeye Lake's share of the Agent's salary for calendar year 1984.

Section 2: The Clerk is hereby authorized and directed to pay to the Licking County Humane Agent the sum of \$5.00 per month for calendar year 1985 and thereafter.

Section 3: This payment referred to in Sections 1 and 2 of this Resolution is being made pursuant to the statutory requirements imposed upon the Village by virtue of Section 1717.07 of the Ohio Revised Code.

Section 4: This Resolution shall go into full force and effect from and after the earliest period allowed by law.
