A RESOLUTION AUTHORIZING COUNCIL TO ENTER INTO AGREEMENT WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES TO ADMINISTER A CERTAIN GRANT FOR LITTER CONTROL.

WHEREAS, The Village of Buckeye Lake has applied for and received an implementation grant from the Ohio Department of Natural Resources; and

WHEREAS, In order to implement that grant, it is necessary that the Council of the Village of Buckeye Lake contract with the Ohio Department of Natural Resources.

NOW, THEREFORE, BE IT RESOLVED BY THE VILLAGE COUNCIL OF BUCKEYE LAKE, COUNTY OF LICKING, AND STATE OF OHIO, That:

Section 1: The Village of Buckeye Lake is hereby authorized pursuant to this resolution to enter into contract with the Department of Natural Resources to administer a litter control grant.

Section 2: The Mayor and Clerk of the Village of Buckeye Lake are hereby authorized and directed to sign the attached contract on behalf of the Village of Buckeye Lake, Ohio.

Section 3: The attached contract is hereby incorporated into this resolution as if fully rewritten herein.

Section 4: This resolution shall go into full force and effect from and after the earliest period allowed by law.
