A RESOLUTION TRANSFERRING FUNDS FROM THE GENERAL FUND TO THE LITTER GRANT FUND.

WHEREAS, due to a cash flow problem in funding the State Litter Grant, Council must transfer money from the General Fund to the Litter Grant Fund to pay the bills of the Litter Grant Program until such time as the General Fund is reimbursed by the grant from the State.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING, AND STATE OF OHIO, That:

- Section 1: Five Thousand and 00/100 dollars (\$5,000.00) is hereby transferred from the General Fund to the Litter Grant Fund.
- Section 2: This Resolution shall go into full force and effect from and after the earliest period allowed by law.
