A RESOLUTION AUTHORIZING THE CLERK/TREASURER AND MAYOR TO ENTER INTO CONTRACT WITH BANCOHIO NATIONAL BANK.

WHEREAS, The Village must renew its depository contract with BancOhio National Bank.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF BUCKEYE LAKE, COUNTY OF LICKING, AND STATE OF OHIO, THAT:

Section 1: The Mayor and Clerk/Treasurer are hereby authorized to enter into contract with BancOhio National Bank for the depositing of village funds in said bank.

Section 2: The provisions of Ohio's Uniform Bank Depository Act are hereby waived in that BancOhio National Bank is the only bank having an office within the corporate limits of the Village of Buckeye Lake, Ohio.

Section 3: A copy of said contract is attached hereto and incorporated herein as if fully rewritten.

Section 4: This Resolution shall go into full force and effect from and after the earliest period allowed.
